## ACCESS AND INCLUSION COMMUNITY PARTNERSHIP PROGRAM

### Brisbane City Council

**Funds:** \$2,000 – \$50,000

**Closes:** Temporarily closed until further notice

**Purpose:** This program is designed to assist community organisations to undertake projects that deliver Council's *Brisbane Vision 2031* and its priorities to maintain or improve quality of life for the Brisbane community, and to ensure that Brisbane has the services and infrastructure to meet the livability and sustainability challenges of the future.

**Eligible applicants:** Incorporated not-for-profit community organisations and networks, or unincorporated groups under the auspices of an incorporated not-for-profit organisation based in the Brisbane local government area; or demonstrate that the activity will take place in the Brisbane local government area.

**Eligible projects:** Must directly benefit residents of the City of Brisbane local authority area and could include: improvements of the accessibility of community facilities, services or venues; support initiatives and partnerships in response to challenges experienced by people with a disability and their carers; remove barriers to access and inclusion in local community sport, recreation, cultural and social activities; remove barriers to inclusion in community services.

## ARMY HISTORY RESEARCH GRANTS SCHEME

### Australian Government – Department of Defence

**Funds:** \$15,000

**Closes:** Closed – check website for next round

**Purpose:** Values new research that identifies how Army specifically has approached challenges in the past, and which is accessible to both Army and the public.

**Eligible applicants:** Individuals.

**Eligible projects:** The areas of research fall into three broad categories: Military Organisation and Operations; Military Social History; Military Heritage and Technology. Grant may be used to cover travel and accommodation costs and research expenses.

**Ineligible projects:** Family history of military service; commemorative projects; artistic works; projects that are limited to a small local or regional audience.

## ARTS AND DISABILITY MENTORING INITIATIVE 2019-21

### Australia Council for the Arts

**Funds:** 6 grants of \$30,000

**Closes:** 6 April 2021

**Purpose:** This program is for individuals with disability undertaking an artistic collaboration involving mentoring. The proposal should lead to a major step forward in the applicant's arts practice, and build foundations for an enduring career. The purpose is to support collaborations that fuel ambition, embolden ideas and innovation, build networks and capacity, and strengthen future works.

**Eligible applicants:** Australian (citizen or permanent resident) artist or arts worker with disability.

**Eligible projects:** Should include a mentoring component. Some examples of activities are: collaboration, professional skills development, residencies, experimentation, creation of new work, creative development, practice-based research, presentation, promotion or marketing, inbound and outbound travel.

## BRISBANE HISTORY GRANTS – THE LORD MAYOR’S HELEN TAYLOR RESEARCH AWARD FOR LOCAL HISTORY

**Brisbane City Council**

**Funds:** \$20,000

**Purpose:** The Lord Mayor’s Helen Taylor Research Award for Local History supports history students and independent researchers undertaking history or heritage projects which have a focus on informing or educating the public about local history or heritage.

**Eligible applicants:** Individuals located in the Brisbane Local Government Area.

**Eligible projects:** Projects that can demonstrate that the grant will be used for community benefit with a public outcome and occur within the Brisbane Local Government Area (LGA) or are able to demonstrate benefits to Brisbane LGA. Individuals must also demonstrate professional research and scholarship.

**Ineligible projects:** Retrospective funding, private commercial ventures, an organisation’s general running costs, equipment alone, event or conference sponsorship, fundraising projects, prizes and award ceremonies, projects that are core program funding responsibility of another level of government, debt repayment.

## BUILDING BETTER REGIONS FUND – COMMUNITY INVESTMENTS STREAM – DROUGHT SUPPORT

**Australian Government – Department of Industry, Innovation and Science**

**Funds:** \$5,000 – \$1 million

**Ineligible projects:** Hospitals, hospices or medical centres; medical research, funding for medical equipment or medical treatments; rescue services; schools, colleges and universities; sponsorship or funding towards a marketing appeal/event or fundraising activities; capital projects, major equipment, appeals and refurbishments; projects that support animals or to promote animal welfare; programs promoting religion; sporting equipment and clubs that do not focus on our target groups.

## CREATIVE SPARKS PROGRAM

### Brisbane City Council

**Funds:** Up to \$10,000

**Closes:** Temporarily closed until further notice

**Purpose:** The grant program aims to support artists, arts workers and creative producers in the development of new work, products and partnerships that extend creative practices; ensure diversity of creative expression is accessible for the Brisbane community; provide cultural, social and economic outcomes that benefit and add value to Brisbane.

**Eligible applicants:** Individual professional artists, arts worker, cultural worker and producers who are residents of the Brisbane local government area and are permanent residents or Australian citizens. Incorporated arts or cultural organisations based in the Brisbane local government area.

Unincorporated organisations, auspiced by an incorporated body that is based in the Brisbane local government area.

**Eligible projects:** There are three funding categories:

- Creative projects – funding for emerging talent for experimentation and risk taking in original and unique projects in any art form that enriches the creative life of Brisbane.
- Creative development – funding to advance the development of a new work, concept, project, collaboration or practice. The project application will provide evidence of outcomes that have the potential to advance career prospects, and may include but not be limited to: presentation, masterclasses, training and mentoring.
- Creative Economy – funding for developed artistic or creative projects to be realised or presented professionally in partnership agreements. The application will provide evidence of a matched funding strategy.
