#### AUSTRALIAN CULTURAL DIPLOMACY GRANTS PROGRAM Australian Government – Department of Foreign Affairs and Trade

 \$10,000 - \$60,000

**Purpose:** To support the economic and social recovery efforts of the Australian creative industries sector and communities adversely affected by the COVID-19 pandemic and/or the 2019-2020 bushfires; promote Australia's economic, artistic and cultural assets to an international audience; influence perceptions of Australia at home and abroad; and build people-to-people and/or institutional links internationally.

**Eligible applicants:** Australian not-for-profit organisation; local government body; state/territory government body; an incorporated association; or an individual.

**Eligible projects:** Research, design and development of grant activity/project; consultations with stakeholders and partners; promotional and outreach activities; communications and translations; performances, exhibitions, webinars, seminars, workshops, publications, recordings and films.

**Ineligible projects:** Project cannot cover: capital expenditure; salaries; ongoing administrative costs; school activities; scholarships.

#### GAMBLING COMMUNITY BENEFIT FUND

Queensland Government – Department of Justice and Attorney-General

**Funds:** \$500 - \$35,000 **Closes:** 30 April 2021, 30 June 2021, 31 August 2021, 31 October 2021

**Purpose:** Grants are allocated to not-for-profit community groups to enhance their capacity to provide services, leisure activities and opportunities for Queensland communities.

**Eligible applicants:** Applications must be from community-based organisations with not-for-profit objectives that is incorporated or registered as an act of parliament (or sponsored by an organisation incorporated or registered as an Act of Parliament).

**Eligible projects:** The Gambling Community Benefit Fund website lists funding priorities for each round. Check the website for updated details.

Priority 1: Items/facilities directly affected, damaged or destroyed by a declared natural disaster in the last 2 years

Priority 2: Equipment and facility improvements

Priority 3: Buses, cars, caravans, boats, tractors, trailers, large mowers, motorbikes and similar items

Priority 4: Community events, training, workshops, festivals, publications and website development

Priority 5: Organisations that have received a grant or grants from the GCBF of more than \$15,000 in the past two years.

**Unlikely to be funded projects:** Salaries and wages; administration expenses such as stationery, postage, office supplies; rent and lease costs; consumable items; uniforms; catering.

**Ineligible projects:** Grant writer fees, contingency costs, repayment of debts and loans, overseas travel costs, project management fees, gifts, funding for a staff or member social event.

#### **QUEENSLAND RESILIENCE AND RISK REDUCTION FUND** Queensland Government – Queensland Reconstruction Authority

Funds:A total of \$19.1 millionCloses:Closed for 2021, check website for next round

**Purpose:** This funding is to help reduce, mitigate and manage the risks of disasters and to make Queensland communities and infrastructure more resilient to disasters.

**Eligible applicants:** Local government bodies, regional organisations of Councils, Queensland Government departments, regional natural resource management bodies, river improvement trusts, incorporated non-government organisations (including volunteer groups) and Queensland-based not-for-profit organisations. Eligible applicants demonstrating a limited capacity to self-fund a project, may be considered for a higher funding percentage.

**Eligible projects:** Projects must deliver resilience, risk reduction, risk mitigation and/or risk management outcomes for Queensland communities.

Infrastructure projects may include:

- roads, bridges, culverts, floodways, causeways, drainage management pump stations, stormwater systems, major drains
- mitigation infrastructure, e.g. stormwater detention, levees
- disaster management equipment, such as emergency generators (with evidence to support voltage required), portable communications kits, lighting towers and frequency radios
- weather warning and monitoring systems and flood warning infrastructure

Non-infrastructure projects may include:

- education programs to help communities plan for, respond to, and recover from disasters
- capacity building programs for local volunteers
- natural hazard modelling, risk assessments and studies, including risk reduction/mitigation options assessments
- recovery capability and/or resilience building programs
- activities to improve disaster-related information sharing, data collection and communication
- strengthening the long-term resilience and wellbeing of disaster-affected residents
- research/studies to identify and address resilience or risk reduction and/or risk management priorities
- bushfire mitigation activities, such as fuel reduction activities and new/upgraded fire trails and breaks
- building and supporting local disaster management and leadership capabilities
- risk management studies suitable for complying with the State Planning Policy requirements for natural hazards, risk and resilience for making or amending planning schemes
- salary of temporary risk reduction and resilience officers within program timelines, and up to no later than 30 June 2023

Funds:Up to \$10,000Closes:25 May 2021, 24 August 2021

**Purpose:** Grants are available for a broad range of grassroots, community-led initiatives that directly and clearly benefit local communities. Applications are accepted on an ongoing basis and assessed quarterly.

**Eligible applicants:** Not-for-profit and community-based organisations in regional and remote Australia.

**Eligible projects:** Projects funded must align with one or more of the following charitable outcomes:

- Bringing people and community organisations together to foster stronger, more resilient communities;
- Fostering and celebrating a sense of identity, diversity and cultural connection within the community;
- Improving community health and social wellbeing;
- Enabling people to develop skills, knowledge and confidence to lead and contribute to the prosperity and renewal of their community;
- Building a sustainable volunteer base and/or supporting the wellbeing of volunteers;

**Purpose:** Grants are available for a broad range of grassroots, community-led initiatives that directly and clearly benefit local communities. Applications are accepted on an ongoing basis and assessed quarterly.

**Eligible applicants:** Not-for-profit and community-based organisations in regional and remote Australia, affected by the Sept 2019 – Feb 2020 bushfires.

**Eligible projects:** Projects funded must align with one or more of the following charitable outcomes:

- Bringing people and community organisations together to foster stronger, more resilient communities;
- Fostering and celebrating a sense of identity, diversity and cultural connection within the community;

#### TACKLING TOUGH TIMES TOGETHER

Foundation for Rural and Regional Renewal

Funds:Up to \$20,000 and \$150,000Closes:25 May 2021, 24 August 2021

**Purpose:** Helps communities access the resources they need to support one another through the ongoing effects of the drought.

**Eligible applicants:** The program has a strong preference to support grassroots organisations based in drought-affected regions over those delivering services to, but not based in affected regions. Projects led by local communities will be given strong preference.

Eligible projects: Project must demonstrate a focus on one of the following activities:

- Building community resilience
- Developing organisational resilience and capacity
- Enhancing environmental sustainability
- Fostering cultural vibrancy
- Lifelong learning and education
- Economic strength
- Improving community health and social wellbeing
