Artel, CPL's (Choice Passion Life) creative industries studio, supports the development of a positive and participatory cultural identity for people with profound and complex disabilities. The studio offers space, instruction and an environment in which this particular community of individuals has been able, over many years, to express themselves as a dynamic artistic movement.

Redcliffe filmmaker and CPL support worker, Jeremy Ruckels, has created an insightful documentary about Artel, which will be screened as part of the touring exhibition.

The exhibition title is taken from National Disability Insurance Scheme (NDIS) criteria. With the uncertainty surrounding the NDIS, Artel creative industries studio is not just *reasonable and necessary*, but *essential*, providing real career prospects for artists.

M&G QLD has been pleased to work with accomplished Curator, Lynne Seear, in the development of this exhibition. Lynne has worked as a senior curator for 30 years, including 16 years at the Queensland Art Gallery | Gallery of Modern Art in management roles. For the past six years, she has worked on a multifaceted Arts Program for Children's Health Queensland as Manager Arts-In-Health.

Reasonable and Necessary: prints and artist books by Artel Artists will tour to eleven venues across Queensland: Redcliffe, Cloncurry, Moranbah, Cairns, Mackay, Emerald, Mundubbera, Brisbane, Redland, Warwick and Lockyer Valley.

Reasonable and Necessary: prints and artist books by Artel Artists is an initiative of Museums & Galleries Queensland in partnership with CPL and curated by Lynne Seear. This project has been supported by the Queensland Government through Arts Queensland; the Visual Arts and Craft Strategy, an initiative of the Australian, State and Territory governments; and the Australian Government through the Australia Council, its arts funding and advisory body. M&G QLD 2018 Standards Review Program

The Standards Review Program is an opportunity for participating museums and galleries to assess their practices and policies against National Standards for Australian Museums and Galleries v1.5, with the aim of becoming valuable and sustainable community assets. The 'health check' for museums and galleries results in each of the organisations developing a plan for the future through completing a series of activities and hosting Reviewers for two visits.

The conference will inspire communities to share and preserve local history from yesterday, today and tomorrow. A blend of presentations, case studies and workshops will stimulate ideas for staff and volunteers to share and put into practice. Networking opportunities and a conference dinner will also be part of the program.

The keynote speaker is Liza Dale-Hallett, Senior Curator, Sustainable Futures, at Museums Victoria. She specialises in the history of rural Victoria, with a particular interest in contemporary issues of sustainability, in particular, the significant contribution of women in agriculture and rural communities. Much of her work has been focused on bridging the gaps between city and country, consumers and producers.

National Arts and Disability Strategy Consultation

When: 13-15 November 2018

Where: Brisbane, Gold Coast and Cairns, QLD

The Department of Communications and the Arts is seeking views on an arts and disability discussion paper to inform a renewed National Arts and Disability Strategy. To learn more about what people and organisations need to support higher rates of access and participation in the arts, a public consultation process is taking place during October and November 2018.

During this time, people with disability, carers of people with disability, and organisations can share

their views through an online survey, provide written, verbal or recorded submissions or attend a face-to-face consultation. The consultations in Queensland will take place in Brisbane, Gold Coast and Cairns.

This is your chance to contribute your ideas on what enables people with disability to engage with the arts; what are the barriers to arts engagement; what are some examples of best practice; and what you think should happen in the future.

■ Commonwealth Child Safe Framework and what it means for your organisation

The Royal Commission into Institutional Responses to Child Sexual Abuse highlighted the need for organisations to adopt child safe practices, including appropriate screening of staff, mandatory reporting and adoption of the National Principles for Child Safe Organisations.

It is therefore timely for organisations to address its policies and procedures for safeguarding children, young people and vulnerable adults accessing their services.

M&G QLD's current policy reflects our commitment to the safety, participation and empowerment of children, young people and vulnerable adults. We believe that all children, young people and vulnerable adults who interact with the Company on or off-site have the right to feel safe and to be safe.

Each organisation's risk management within this context should aim to remove or minimise potential risks to the safety and wellbeing of any children, young people and vulnerable adults who are involved in your activities. This entails identifying and analysing hazards, assessing the risks associated with those hazards and identifying strategies to control, remove or minimise the risk.

Organisations should ensure that any staff member, volunteer or contractor working with children and young people undertake the appropriate compliance checks (e.g. holding a Blue Card in Queensland).

In each Australian state and territory, working with children (or working with vulnerable people, including children) is governed by legislation applicable in that state or territory.

The rules that govern checks for working with children or vulnerable people, known variously as working with children checks (WWCC) or working with vulnerable people checks (WWVP) depending on the jurisdiction, differ in each Australian state and territory.

These WWCCs and WWVPs are not transferable between Australian states and territories. Accordingly, as a general rule, organisations or individuals that work or volunteer with children across state or territory boundaries need to ensure that they have obtained appropriate clearance checks and screenings for each separate jurisdiction.

However, there is an exception to this general rule. In 2012, Australian state and territory governments agreed on a standard exemption that allows individuals to work interstate for a brief period of time being up to 30 days in a 12-month period without obtaining a WWCC in the new location.
